Operations Manual

Important Safety Instructions

1. Read these instructions.
2. Keep these instructions.
3. Heed all warnings.
4. Follow all instructions.
5. Do not use this apparatus near water.
6. Clean only with a dry cloth.
7. Do not block any ventilation openings. Install in accordance with the manufacturer's instructions.
8. Do not install near any heat sources such as radiators, heat registers, stoves, or other apparatus (including amplifiers) that produce heat.
9. Do not defeat the safety purpose of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. A grounding-type plug has two blades and a third grounding prong. The wide blade or the third prong are provided for your safety. If the provided plug does not fit into your outlet, consult an electrician for replacement of the obsolete outlet.
10. Protect the power cord from being walked on or pinched particularly at plugs, convenience receptacles, and the point where they exit from the apparatus.
11. Only use attachments/accessories specified by the manufacturer.
12. Use only with a cart, stand, tripod, bracket, or table specified by the manufacturer, or sold with the apparatus. When a cart is used, use caution when moving the cart/apparatus combination to avoid injury from tip-over.
13. Unplug this apparatus during lightning storms or when unused for long periods of time.
14. Refer all servicing to qualified service personnel. Servicing is required when the apparatus has been damaged in any way, such as power-supply cord or plug is damaged, liquid has been spilled or objects have fallen into the apparatus, the apparatus has been exposed to rain or moisture, does not operate normally, or has been dropped.
15. This apparatus shall not be exposed to dripping or splashing, and no object filled with liquids, such as vases or beer glasses, shall be placed on the apparatus.
16. Do not overload wall outlets and extension cords as this can result in a risk of fire or electric shock.
17. This apparatus has been designed with Class-I construction and must be connected to a mains socket outlet with a protective earthing connection (the third grounding prong).
18. This apparatus has been equipped with a rocker-style AC mains power switch. This switch is located on the rear panel and should remain readily accessible to the user.
19. The MAINS plug or an appliance coupler is used as the disconnect device, so the disconnect device shall remain readily operable.

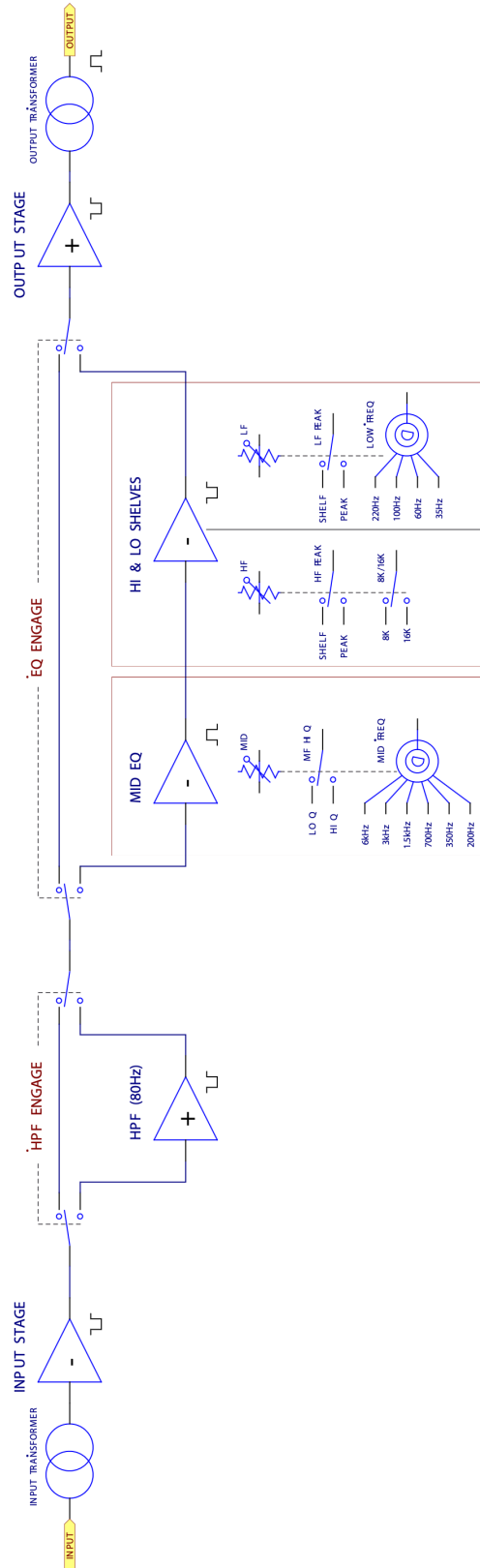

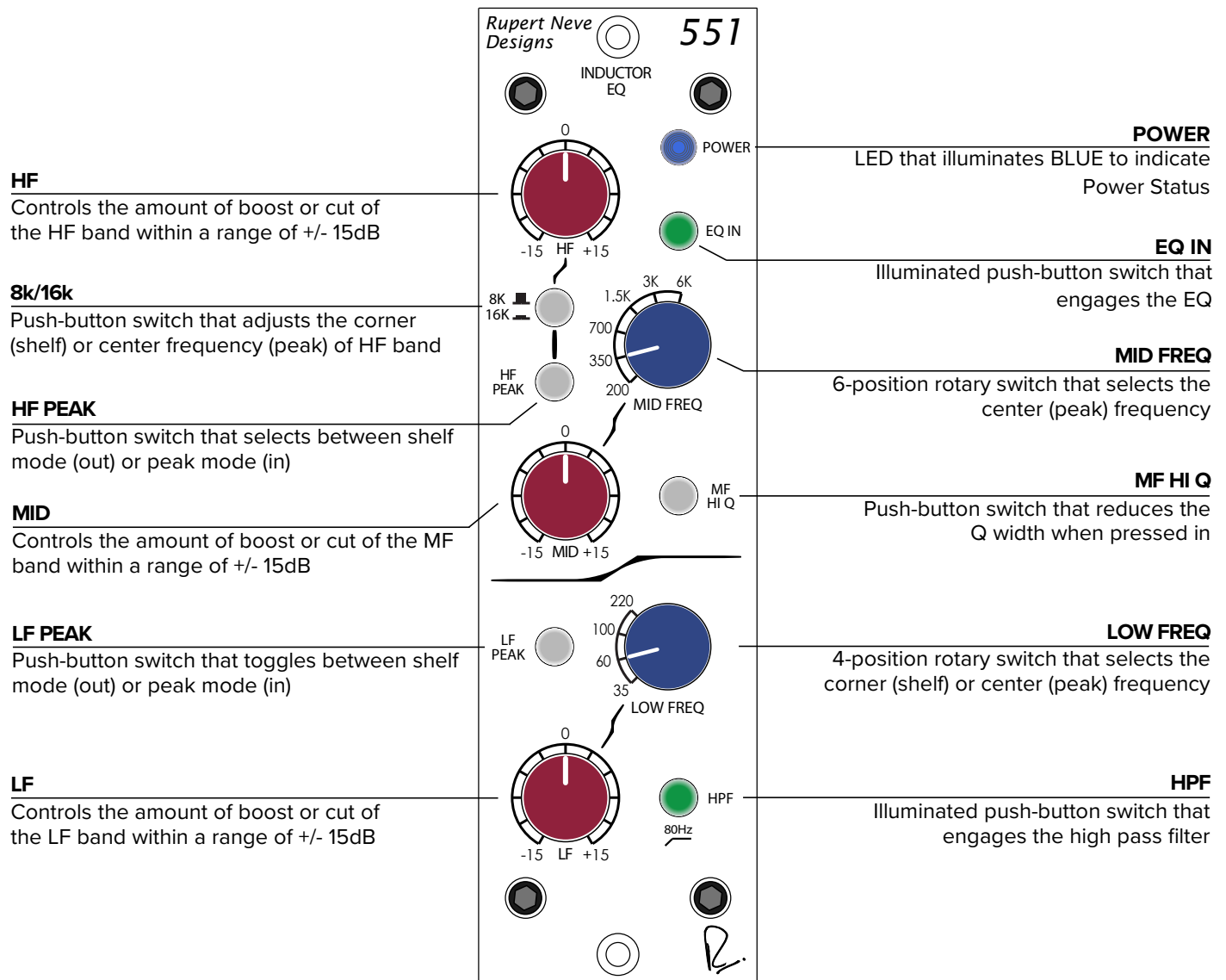

Rupert Neve Designs 551: Inductor EQ

Thank you for purchasing the Rupert Neve Designs 551 Inductor EQ. We hope you enjoy using this product as much as we have enjoyed designing and building it. The 551 circuitry was originally designed for the equalizer section of our highly acclaimed Sheldford Channel. Each of the 3 bands were inspired by Rupert's highly coveted vintage EQ designs. The low-band includes 4 frequency selections and switches from a shelf to a peak, the mid-band includes 6 frequency selections and our 'proportional' Q, and the high-band is a hybrid design using both inductor and capacitor topologies to impart a vintage tone with enhanced control.

551 Front Panel Features

POWER

LED that illuminates BLUE when the 551 is powered on.

HF

Center-detent potentiometer that controls the amount of boost or cut for the high frequency band within a range of +/- 15dB.

EQ IN

Push-button switch that illuminates GREEN when the inductor EQ section is engaged.

8K/16K

Push-button switch that selects between the two available high frequency shelf/peak frequencies: 8kHz (OUT) and 16kHz (IN).

MID FREQ

6-position rotary switch that selects the center (peak) frequency of the mid frequency band.

HF PEAK

Push-button switch that toggles between shelf mode (OUT) or peak mode (IN) of the high frequency band.

MF HI Q

Push-button switch that reduces the Q width of the mid frequency band when pressed in.

MID

31-detent potentiometer that controls the amount of boost or cut for the mid frequency band within a range of +/- 15dB.

LF PEAK

Push-button switch that toggles between shelf mode (OUT) or peak mode (IN) of the low frequency band.

LOW FREQ

4-position rotary switch that selects the corner (shelf) or center (peak) frequency of the low frequency band.

LF

Center-detent potentiometer that controls the amount of boost or cut for the low frequency band within a range of +/- 15dB.

HPF

Push-button switch that illuminates GREEN when the high pass filter is engaged.

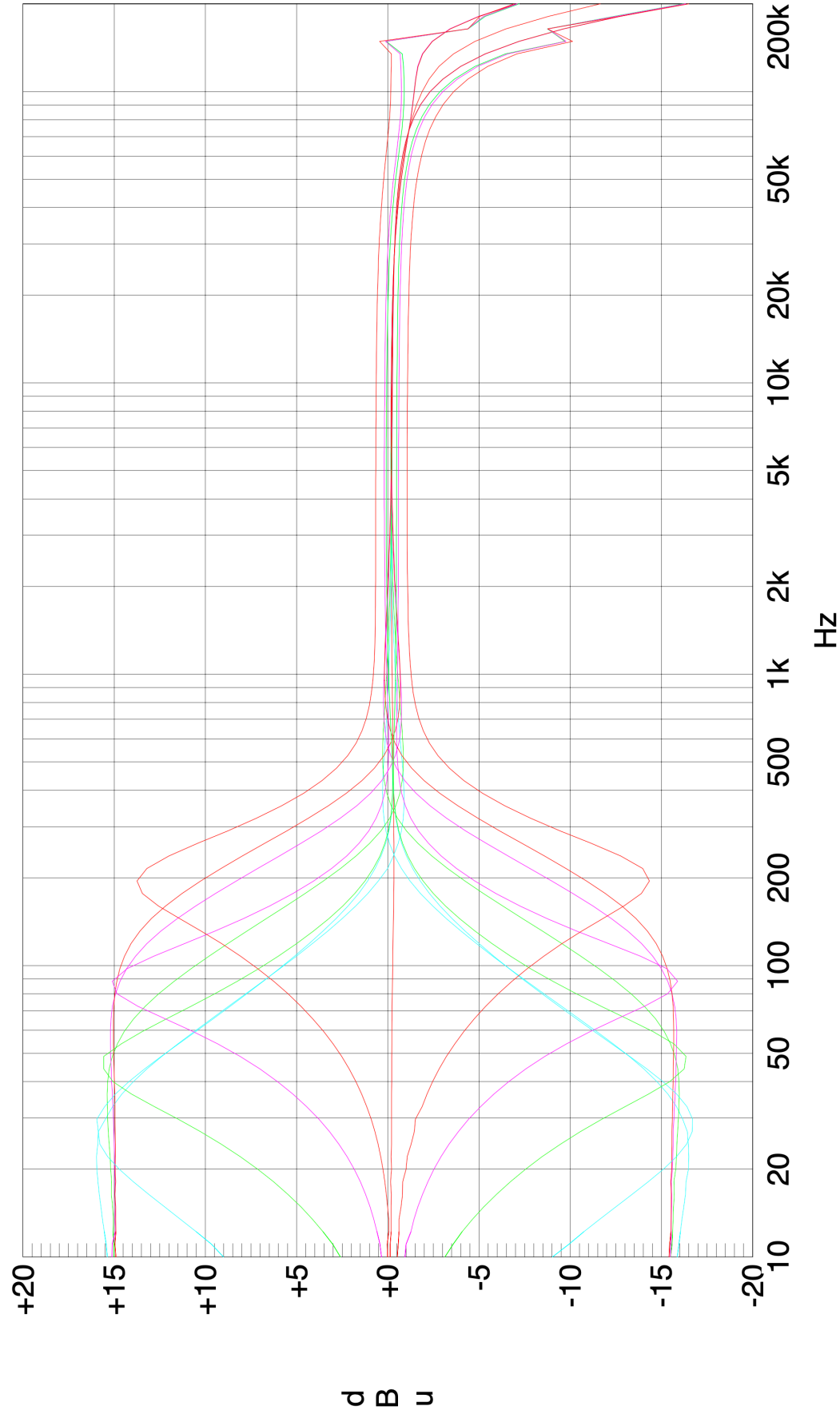

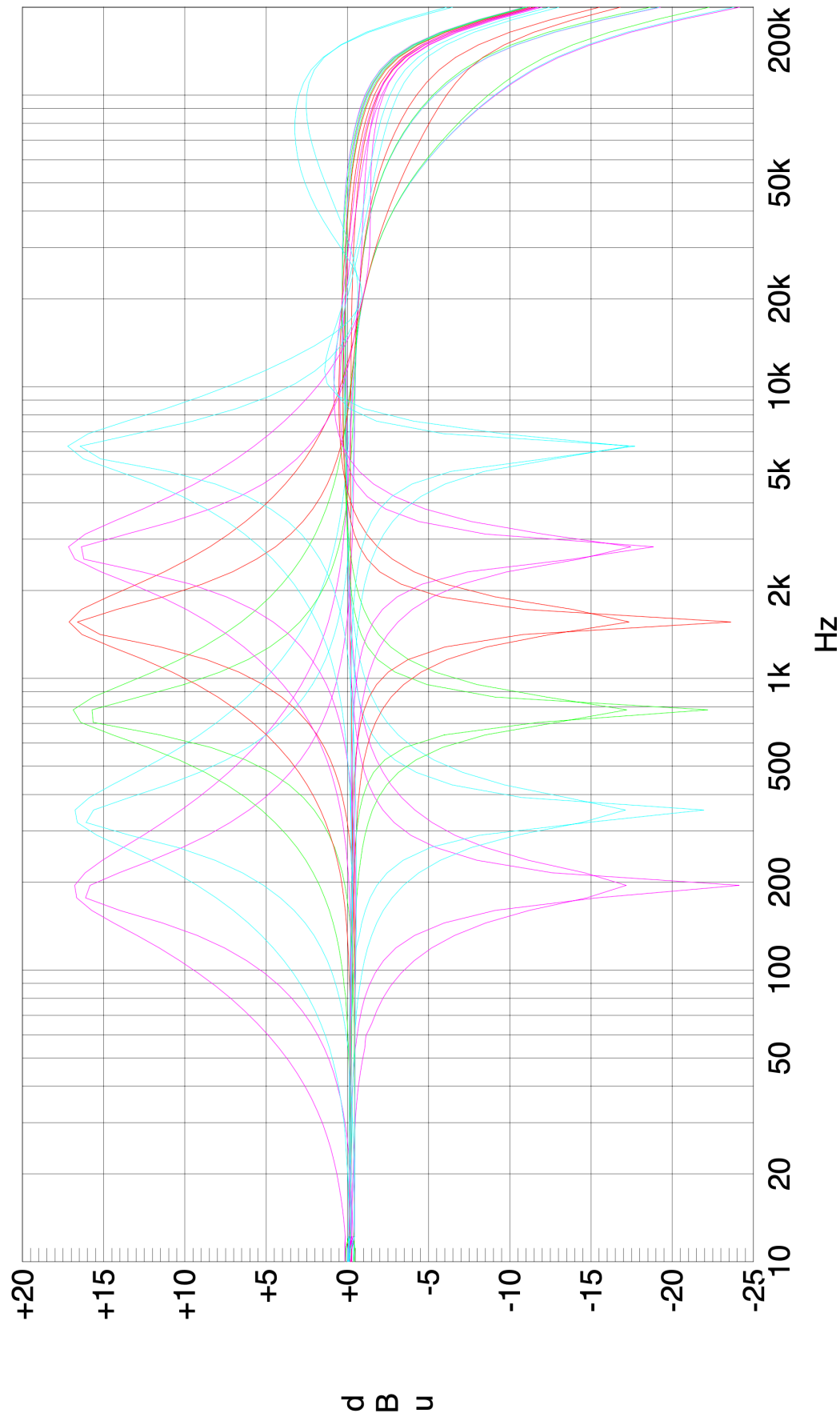

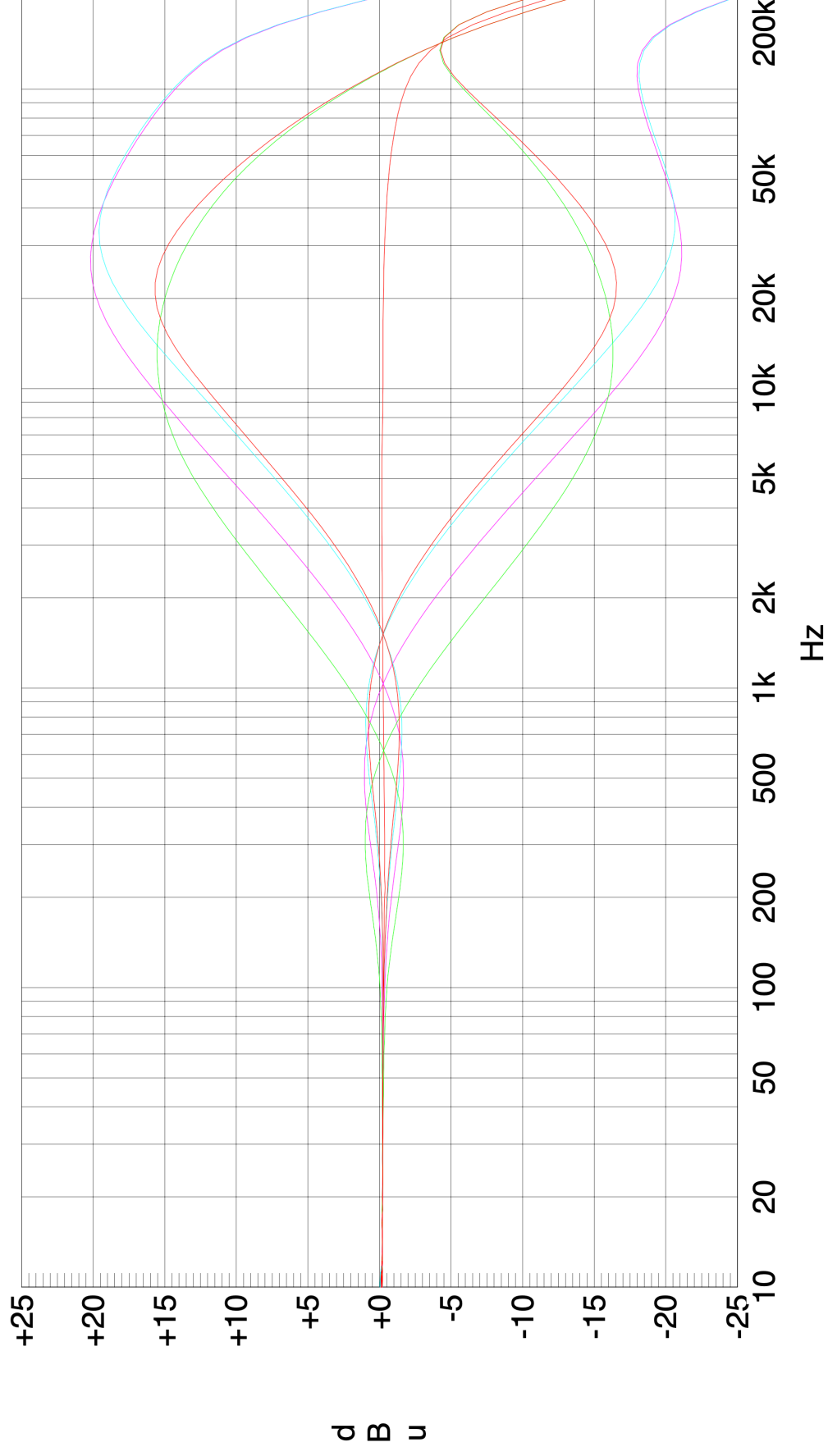
